

#### Introduction

The International Law Students Association is a non-profit association of students and lawyers who are dedicated to the promotion of international law. ILSA provides students with opportunity to study, research, and network in the international legal arena. The organization's activities include academic conferences, publications, the global coordination of student organizations, and the administration of the Philip C. Jessup International Law Moot Court Competition.

- 1. To encourage communication among students and lawyers from different parts of the world in an effort to promote international understanding and cooperation in general, and the advancement of legal education in particular
- 2. To contribute to legal education, to foster mutual understanding, and to promote social responsibility of students and lawyers
- 3. To provide opportunities for law students and lawyers to learn about other cultures and legal systems in a spirit of critical dialogue and international cooperation;
- 4. To assist law students and lawyers to be internationally-minded and professionally skilled
- 5. To assist in and encourage the development of international career resources and opportunities for internationallyminded students and lawyers
- 6. To engage in other activities related to the development and promotion of international law, study, and practice generally

#### SUBMISSION GUIDELINES

We welcome submissions under the following categories, with word limits:

- 1. Long Articles (between 7,000-15,000 words including footnotes)
- 2. Short Articles (between 3,000-7,000 words including footnotes)
- 3. Essays (2000-3000 words including footnotes)
- 4. Book Reviews (1000-2000 words including footnotes)
- 5. Case Commentaries (1000-3000 words including footnotes)
- 6. Policy Reviews (No word limit)

Co-authorship of papers is welcomed but only limited to three Co-authors.

The **SUBMISSIONS** may be in the form of articles, notes, comments, book reviews on the issues raised.



#### Submissions must include-

- 1. Cover letter including:
- i. Title of the Paper
- ii. Abstract (not exceeding 250 words)
- ii. Name of the Author
- v. Designation
- Correspondence address.
  Co-authored papers should give full details about all the authors
- 2. Article should contain a disclaimer to the effect that the submitted paper is original and is not been published or under consideration for publication elsewhere.

- All citations shall be placed in footnotes and shall be in accordance with The Bluebook:
   A Uniform System of Citation, 19th Ed.
- 4. All submissions will go through an initial round of review by the editorial board and the selected pieces will subsequently be sent for peer-review before finalisation for publication.

#### **Review Process**

#### SOCPE AND RELEVANCE

The article must be based on issues revolving around sports law, policy and other allied areas. Content of articles must be suitable for readership among students, practitioners and academicians alike. Submissions using offensive language and defamatory references will be rejected.

#### LANGUAGE AND QUALITY

Only submissions in English are allowed. The language of the submissions should also be formal and clear, adhering to the submissions guidelines of journal.

#### **COPYRIGHT VIOLATION**

To ensure that, the submissions are not in violation of copyrights laws, the authors are required to obtain written permission for the use of any copyrighted material in the manuscript and the same must be communicated to the journal. All disputes are subject to local laws and jurisdiction.

#### **REVIEW PROCESS**

Submitted manuscripts undergo double blind peer review process in order to determine whether the subject matter fits within the scope of the Journal and to assess the quality of the manuscript. The Editor will remove all identifying information from a submitted manuscript before submitting it to reviewers. Some categories of manuscripts, such as solicited book reviews, may be subject to a modified form of peer review. The decision on publication will be solely at the discretion of the Editorial Panel. We hope to bring condor and dynamic law journal which can make a majestic aid towards opening new avenues in the field of sports law.
